

## Discipline Policy

#### Introduction:

The Behaviour Policy of Al-Baqir Institute outlines the expectations, guidelines, and procedures for student behaviour within the institute premises. Rooted in the teachings of Islam, this policy aims to foster a positive, respectful, and conducive learning environment that promotes the well-being and academic success of all students while embodying Islamic values.

#### Behaviour Expectations:

All students at Al-Baqir Institute are expected to embody Islamic values, including:

1. **Taqwa (Consciousness of Allah):** Demonstrate mindfulness of Allah ﷺ in their actions, speech, and interactions, striving to please Him ﷺ in all endeavours.
2. **Adab (Respect and Courtesy):** Treat fellow students, staff, and visitors with respect, kindness, and consideration, mirroring the noble character of the Beloved Prophet Muhammad ﷺ.
3. **Shukr (Gratitude):** Express gratitude to Allah ﷺ and others for blessings and opportunities.

#### Prohibited Behaviours:

In addition to the expectations rooted in Islamic values, the following behaviours are strictly prohibited within the institute premises:

1. **Bullying and Harassment:** Engaging in any form of bullying, harassment, or intimidation contradicts the teachings of Islam and will not be tolerated.
2. **Disruption:** Disruptive behaviour that hinders the learning of others or the institute's functioning.
3. **Dishonesty:** Cheating, plagiarism, lying, or any form of dishonesty.
4. **Vandalism:** Damaging property of the madrassah or any other students will financially be reimbursed by the perpetrator.
5. **Substance Abuse:** The use of drugs, alcohol, vapes, or any other intoxicants.

6. **Violence:** Any form of physical, verbal, emotional abuse.

### **Consequences:**

Violations of the Behaviour Policy may result in disciplinary actions, aligned with Islamic principles of justice and rehabilitation, including:

1. **Counselling and Guidance:** Providing guidance to help students recognise and rectify their behaviour.
2. **Restitution:** Encouraging students to make amends for their actions.
3. **Reflection and Repentance:** Encouraging sincere reflection and seeking forgiveness from Allah ﷺ.
4. **Parent/Guardian Involvement:** Involving parents or guardians to collectively address any issues that arise.

### **Suspension or Probation:**

In cases of continued misconduct, temporary suspension or probation may be considered to facilitate behaviour improvement.

### **Positive Reinforcement:**

Al-Baqir Institute recognises and encourages positive behaviour. This includes commendations, awards, and acknowledgment of virtuous conduct.

### **Modification of Policy:**

Al-Baqir Institute retains the right to modify or update this Behaviour Policy as needed, in harmony with Islamic teachings. Changes will be communicated through our official channels.
